

## **Sioux City 300 Driver Information**

- The Sioux City Enduro will take place Saturday, July 31, at the Park Jefferson Speedway in Jefferson, South Dakota
- Race distance is 300 laps or 3 hours with standing starts and restarts.
- \$5,000 to win purse will be paid out at the conclusion of the race at the pit shack.
- Purse is paid out once results are official at pit shack.
- RV parking/camping is available either in pits or in main lot. Camping will be \$10.
- Park Jefferson Speedway has concessions, bathrooms and a catwalk.
- Out-of-town travelers can show up Friday after 12pm to set up in pits.
- Mandatory drivers meeting at 5:00 p.m. (in clubhouse)
- Mandatory scorers meeting at 5:30 p.m. (in clubhouse)
- Each scorer MUST have a pit pass. One (1) scorer is required for each car. Video loops are used to verify score cards.
- Cars line up each night at 5:45 p.m. WE START ON TIME
- The event will be broadcast live online at Speed Sport TV
- RACEceivers are not required but are STRONGLY encouraged.
- No cautions. The race stops only for cars blocking most of the track, fires, flips, safety concerns or major accidents. Red flag will be displayed.
- Pitting is allowed. Driver changes are allowed. Rules are all safety related.
- Mascots, decorating cars, advertising nicknames, cartoons, etc. are encouraged. Mascots and decorations must be secured to not fall off on track will racing.
- No suggestive language, symbols, or numbers allowed on car.
